7.1 Bus Shelter

It was agreed that a proposal from Richmond Roofing to build a wooden frame over the existing concrete slab, fix 18mm Sterling board, fix white upvc fascia, fix dark grey finish roof deck GRP roofing system, should be accepted if funding could be sourced. SP to approach AT Locality Budget and National Lottery. KR to source alternative quote. SP to check with the planning department if planning permission is required.

A letter from Camfero Homes, dated 23rd August 2022 confirming their plans as discussed at a site visit with ClIrs, Moreton, Budden, and Richards, attended on 18th August 2022, was received. It was agreed that the use of grasscrete was an acceptable way of re-instating the village green whilst allowing for a right of access to the new parking area. SP to write to Camfero Homes confirming the boundary line of the village green and a reminder that the village green continues to be subject to the laws of registered village greens and bylaws of the parish council.
